#### Eligibility Criteria, limitations and selection procedure

- (i) Life Member of the Indian Botanical Society.
- (ii) This award is open only to the lady botanists.
- (iii) Age below 50 years as on 31<sup>st</sup> December of the year of award.
- (iv) High quality research / extension / documentation work in any area of botanical sciences. Work done in India shall be given preference.
- (v) Submission of **single authored manuscript** based on the work done, including published and unpublished work, as the background material for the proposed presentation.
- (vi) All the applications submitted as per the given proforma shall be screened. Only three selected applicants shall be invited for presentation. In exceptional cases, a fourth applicant may be invited if the number and quality of applications is very high. The decision of the Secretary and the President of the Society shall prevail.
- (vii) The applicant shall have **18 minutes** time for oral presentation followed by the discussion. Final selection shall be based on the recommendation of a three member committee of judges appointed for the purpose.
- (viii) Application should be submitted as per the proforma given below, accompanied by proof of Life Membership and Date of Birth.
- (ix) No column of the application proforms should be left blank; if not applicable then write NA
